- SB 1442 issues

 - Communications to store directors about obtaining the pharmacy and pharmacist schedule in order to create accurate call sheets

- Details on the training portion (didactic/ACIU training and OJT) for VG injections

 - Need for front end to review rx schedule before doing there's
- Medication administration (VG)
 - No longer didactic portion?
- Incident reporting form too complicated
- Punches being adjusted
 - Rounded to closest interval of 15 (Jessi has examples)
- Butalbital now non control*** EPS hard halts
 - Need to confirm heard from pharmacy intern
- Image notes don't appear on refills
- Spanish translation rarely works incorrect or bad translations when it does
 - Ves instead vez
 - Other translations and paperwork?
- Rebilling partials
 - Incident reporting for 1qd; "por boca" vs oralmente
 - No additional paperwork prints out in the other language
 - Other languages are also included as requirements under CA law
 - Some systems allow for toggling between English and patient's preferred language
 - Someone is emailing Chi to follow-up
- Advanced notice when non-regular staff are in pharmacy
 - Water filter changes, work in pharmacy, etc.
